Executive Summary

Major corporations and startups in the Nigerian economy consolidated on the deal making successes recorded in the previous year (FY 2020 saw 106 deals valued at \$4.3 billion/N1.6 trillion), with even more record breaking deals in 2021.

Specifically, in 2021, Nairametrics captured 177 deals valued at \$8.88 billion or N3.65 trillion. In other words, the deals value of \$8.88 billion in the review year, represents 106.5% increase compared to the \$4.3 billion deals value recorded in 2020.

This deal making pace is noteworthy and remarkable considering especially the backdrop of a challenging business environment in Nigeria, which impacted various indicators across 4.03% GDP growth rate for Q3 2021 (Baseline effect), inflation rate of 15.4% for November 2021 and unemployment of 33.3% as at Q4 2020.



Also, the stock market was only able to print a 6.07% growth in the review year despite growing by over 50% in 2020, while the official exchange depreciated by 6% to close at N435/\$1.

This pace of deal making trend further demonstrates continuing appetite for businesses serving Nigerian consumers as investors who are awash with surplus funds from the various quantitative easing programs across the globe seek to better utilize available liquidity.

Deals Overview (Q7-2027)

There were 25 reported deals compiled in Q1 2021

Nigerians were welcomed into the new year with the announcement of Ardova Plc's 100% acquisition of Enyo Retail & Supply Limited, a fuel retailing company in January 2021, although it took about eleven months before the deal was completed later in November.

The acquisition makes Ardova the largest indigenous publicly listed downstream company in Nigeria after adding Enyo's 95 retail stations to its already existing 450 stations.

Similarly, major tech firms operating in the country also raised significant fundings to scale up their businesses. For example, payments company Flutterwave became the fourth African startup to reach unicorn status after it raised \$170 million series funding, led by American-based private investment firm, Avenir Growth Capital and U.S hedge fund and Investment firm, Tiger Global.

The company had also raised \$35 million series B funding in the previous year, processing over 107 million transactions worth \$5.4 million. The CEO of the company has also hinted on the possibility of

listing on the New York exchange or a dual listing alongside in Nigeria.

Also, Total Energies formerly Total Nigeria raised N15 billion through the issuances of two commercial paper series under its N30 billion CP issuance programme. Some of the other deals recorded in the first quarter of 2021 were Cowrywise (\$3 million), uLesson (\$7.5 million), Daystar Power (\$38 million) amongst others, summing up to \$2.58 billion across 25 deals.

In summary, Nairametrics

captured 25 deals valued at \$2.58 billion most of which were seed fundings in terms of number of deals. However, acquisition printed the highest fund value in the period, accounting for 42.7% of the total value of deals consummated in Q1 2021.

Deals Overview (Q2-2021)

The second quarter of the year saw notable deals across various sectors in the Nigerian business space, capturing a total of 32 deals valued at \$2.1 billion, most of which were in form of seed/series fundings by startups. However, the value weight of capital raised by existing corporations from the capital market, which made Nigerian corporates raised a sum of \$1.7 billion from bond issuances, representing 80% of the total value of deals recorded in the review quarter.

Notable amongst these deals is the successful completion of the N110 billion series 1 seven-year fixed bond by Nigerian telco giant, MTN Nigeria under its N200 billion bond issuance programme. The programme which was positively received by the investing public recording a total order of N132.15 billion, representing a 1.32 times oversubscription compared to the intended capital raise of N100 billion. In the same vein, Nigerian cement giant Dangote Cement raised N155 billion from its series 1 fixed rate senior unsecured bonds. The fund raised by the industrial giant was used to refinance the company's already existing short-term debt and facilitate expansion projects.

In the same period, Bua Cement recorded a 37% oversubscription to the tune of N137.8 billion in April 2021 through its 7-year series 1 unsecured bond issuance, under its N200 billion programme.

However, while Nigerian mega corporations were raising funds through commercial paper and bond issuances, startups such as Mono, Chipper Cash, Okra, Bfree, CribMD amongst others, raised fundings through seed and series rounds. Meanwhile, the acquisition of Shoprite Nigeria by Ketron Investment Limited and Jiji acquiring Cars45 were announced in the second quarter.

Deals Overview (Q3-202])

There were 52 reported deals compiled in Q3 2021



A total of 52 deals were captured in the third quarter of 2021, summing up to \$1.56 billion (equivalent of N642.2 billion), representing a decline compared to the previous quarter in terms amount of capital raised. However, taking into account the number of deals reported in the review period, it represents the second highest number of deals, behind the 68 deals recorded in Q4 2021.

Most of the deals recorded in the review period were seed/series fundings amounting to \$386.2 million. For example, Nigerian mobility start up Moove, raised a \$63.2 million Series A debt and equity funding round intended for the expansion of its operation. Similarly, Nigerian fintech startup, FairMoney, raised a \$42 million Series B round following the €10 million Series A round it raised two years ago and €1.2 million seed in 2018.

The quarter also recorded some acquisitions, one of which includes Leading savings and investment startup, PiggyVest acquiring a

smaller but promising wealth management startup Savi. ng in order to grow its local customer base, although the financial value of this acquisition was not revealed by the company.

Also, Nigerian automotive tech company, Autochek which acquired Cheki Nigerian and Cheki Ghana in 2020 continued its expansion plan by acquiring Kenyan and Ugandan Cheki for an undisclosed amount.

Deals Overview (Q4-2021)

The last quarter of the year recorded the highest number of deals and highest interms of value, witnessing the consummation of 68 deals valued at \$2.62 billion, most of the funds which came in through bond issuances. The last lap of the year saw notable deals with 11 acquisitions captured by Nairametrics and 36 seed/series fundings.

One of the noteworthy deals in the quarter under review includes the \$100 million series A funding raised by crypto listing platform, CoinList thereby bringing its valuationto\$1.5billion.Thelargest bank by asset value, Access Bank issued a \$500 million Eurobond in October 2021, priced at 9.125%, following a similar issue in less than two weeks. Nairametrics also captured the acquisition of Disha by Flutterwave, Meddy by Helium Health, AgroEknor by Aruwa Capital, amongst others. Meanwhile, Mono an open banking platform for Africa raised a \$15 million Series A round led by Tiger Global to power the digital economy in Africa after five months of closing \$2 million in seed investment.

Similarly, Verto, a Nigerian-based B2B payments startup, raised \$10 million in a Series A round. Remarkably, MTN Nigeria completed the issuance of its N89.999 billion Series II 10-year bond with a fixed rate of 12.75% due by 2031. The series, which represents the second bond issuance this year by the telco giant following the debut in May 2021. In the same vein, telecommunication giant, Airtel Africa raised an additional \$125 million in the second phase of its minority investment transactions with TPG's The Rise Fund, Qatar Investment Authority (QIA) and Mastercard, through the sale of shares in its mobile money venture.
